The board and staff have to work as a team in order for a co-op to be successful. One way to make sure that happens is for everyone to be clear on the difference between governance and management. This workshop will highlight that difference while also discussing staff evaluations, training, the role of the Staff Liaison Officer and contracts. We will also hear from a lawyer about legal issues such as Employment Standard Act requirements, human rights accommodations and more. This workshop will benefit members from co-ops that hire their own staff, as well as co-ops that employ property management companies.

Fraud prevention
